The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of the application.
- (c) The pay of the officers selected on deputation basis will be governed in accordance with DoP & O.M. No. 3(19)/2009-Estt.(Pay-II) dt. 17.06.2010; as amended from time to time.
- (d) While forwarding the application of the eligible candidates, ACRs for the last five years may be annexed by the forwarding officer.

The pay of the Officer / staff selected will be governed in accordance with DoP&T, O.M. No. 3(19)/2009-Estt.(Pay-II) dt. 05.04.2010, as amended from time to time.

The maximum age limit for the re-employment on contract basis is 64 years. The appointment of the retired Government Officers / Officials will be made only on contract basis on usual terms and conditions and fixation of pay. The gross pension may be deducted from the pay fixed. Such appointments will be made for a maximum period of one year or till the posts are filled up as per the Recruitment Rules or regular basis; whichever is earlier.
