1. This application has been filed by the Respondents in O.A. No.—85/2016 for incorporating certain typographical corrections in the Order passed by this Bench dated 05.09.2018. Those typographical errors occurred due to the incorrect rank mentioned in the O.A. by the applicant as Flight Sergeant (JWO).

2. The following corrections are hereby ordered : -

(a) In the Cause Title.

For : - No.-255208 Ex Flight Sergeant

Read : - No. 255208 Ex Sergeant.

(b) In the Order at Para 1 Line 4.

For : - Junior Warrant Officer(J.W.O.)

Read : - Sergeant (Sgt).

(c) In Para 2—delete sentence—

*“On successful completion of training and after completion of required courses and qualifications, he was promoted to the post of Flight Sergeant, which corresponds to the present rank of Junior Warrant Officer (J.W.O.)”*

(d) Also, wherever in the entire order dt. 05.09.2018 (excluding set out portions and other cause titles) wherever the rank of ‘JWO’ or ‘Flt Sgt’ is mentioned, the same is to be corrected as ‘Sgt’.

(e) In Para 10, Line 5,

(i) For 'w.e.f. the date of retirement i.e., 12.04.1982.

(ii) Read 'w.e.f. 01.01.1996 in accordance with the policy laid down in GOI letter dt. 09 February, 2001.

3. With the directions as mentioned above, this M.A. (M.A. No. – 18/2019) is disposed off.

4. Application is thus stands allowed.

5. No order as to costs.
