ORDER

**PER LT GEN GAUTAM MOORTHY, PVSM, AVSM, VSM, ADC,
MEMBER (ADMINISTRATIVE)**

1. This case (O.A. No. – 173/2018) has been filed by the applicant under Section 14 of The Armed Forces Tribunal Act, 2007 (The Act) for non grant of pension of the rank of Honorary Naib Subedar w.e.f. 26 January, 2000 (The date the Hony Rank was awarded to the applicant, i.e., on the eve of Republic Day 2000) by the Govt. of India in recognition of his hard work, devotion to duty a meritorious services. The same has been duly conveyed to the applicant vide OIC Records, Signals Records vide his D.O. letter No. 3454/CA-4/11/DO/RD-2000 dated 28 January, 2000 (Annexure : A/3 of the O.A.).

Facts of the Case

2. The facts of the case are that the applicant was enrolled in the Indian Army in the Corps of Signals on 19 September, 1975 as a Signalmán (O.K.L.) and he was subsequently attested on 15 November, 1976. During the course of his service, he was promoted to the rank of Havildar. On completion of 24 years and 12 days of qualifying service, the applicant was discharged on completion of his terms of engagement on 01 October, 1999. He was duly issued with his P.P.O. and discharge book on retirement. At a later date, in keeping with the policy in vogue, a Corrigendum PPO was issued (PPO No.

S/CORR/005823/2000 (ARMY) dated 25 July, 2000 (Annexure – A/3 of the O.A.), wherein the rank of the applicant had been shown as Hony Nb Sub. As per his submission, his pension has not been revised to Honorary Naib Subedar w.e.f the date of grant of the rank i.e., 26 January, 2000 but it continued to be that corresponding to the rank of Havildar. The only change was that the service element of his pension was increased by Rs. 100.00 per month.

3. The applicant vide an appeal dt. 25th June, 2018, through his Ld. Counsel had approached the Chief of the Army Staff, Integrated HQ of MoD (Army), DHQ New Delhi – 110 011 and to the OIC Records, The Signals Records, PIN – 908770, c/o 56 APO (Annexure – A/5 of the O.A.) for grant of pension corresponding to his present rank i.e., Hony Naib Subedar. The Records Signals vide letter No. 14294419F/SP/NER/T-1 (Imp) dated 03 August, 2018 (Annexure – A/6 of the O.A.) had refused granting the applicant's pension in the present rank i.e., Honorary Naib Subedar. The above letter is reproduced below : -

**GRANT OF SERVICE PENSION IN RESPECT OF
NO-14294419 EX HAV & HONY NB SUB G N SARKAR**

1. Refer to your Legal Notice dated 25 Jun 2018 served by Mr. MK Sikdar, Advocate on your behalf.

2. It is intimated that, as per government of India, Ministry of Defence letter No. 1(8)/2008-D(Pen/Policy) dated 12 June 2009, Hony rank of Nb Sub granted to Hav will notionally considered a promotion to the higher grade of Nb Sub and benefit of fitment in the pay band and higher grade will be allowed notionally for the fixation of pension only. The letter was issued in pursuant to Govt decision on the recommendations of the 6th CPC. Since recommendation of 6th CPC were implemented wef 01 Jan 2006, the provisions of above Govt letter are applicable to Hav granted Hony rank of Nb Sub wef 01 Jan 2006.

3. Since you were retired before 01 Jan 2006, the *ibid* benefit is not applicable in your case. Further, benefit of said order of Hon'ble AFT is applicable to the petitioner / applicant only.

4. On receiving the above reply, the applicant seeing no other alternative approached this Tribunal for grant of pension in the rank of Honorary Naib Subedar as entitled through this Original Application being No. 173 of 2018.

Analysis and Order

5. The issue of grant of pension in the rank of Hony Naib Subedar to the personnel who were discharged as Havildar is no longer res-integra. In view of the catena of judgments, Govt. of India, Ministry of Defence, Department of Ex-servicemen Welfare, D (Pension/Legal) letter No. 3(8)/2013/D (Pension/Legal) dated 30 October, 2017 also extended this benefit with regard to the pension of Hony Nb Sub to those Havildars who were discharged pre-2006, from 01.01.2006 onwards.

6. Hence, there is no requirement of calling for the Respondents to file any Affidavit-in-Opposition.
7. The applicant is entitled to the revised pension w.e.f. 01.01.2006. Therefore, his pension is to be revised by the Respondents within a period of 3 months from the date of receipt of this order, and be paid along with arrears failing which, a simple interest @ 8% per annum to be paid to the applicant till the date of realization.
8. It is also made clear that an amount of Rs. 100/- per month which was already paid to the applicant in terms of Govt. of India, Ministry of Defence letter dt. 06.11.1991 shall be adjusted against the amount due to the applicant as per this order and the said amount of Rs. 100/- per month as paid shall be discontinued.
9. Accordingly, this Original Application (O.A. No. – 173/2018) is allowed the directions as above.
10. The O I/C Legal Cell has made an oral prayer for appeal to the Hon'ble Supreme Court under Sec 31 of the AFT Act. As there is no point of law of general public importance, the appeal is denied.
11. No order as to costs.

12. A plain copy of this order, duly countersigned by the Tribunal Officer, to be furnished to both the sides after observance of all usual formalities.
